MINUTES REGULAR MEETING June 2025, July 2025

a. Occupancy

Section 8 Rental Vouchers June 2025

The reports indicated 187 units (76.63%) of the authorized 244 units under lease for the month of June 2025. The waiting list is currently carrying 490 applicants. The report also indicated a current lease-up of 187 units (76.63%) for June 2025.

Portables: In-0, Out-0.

Section 8 Rental Vouchers July 2025

The reports indicated 194 units (79.5%) of the authorized 244 units under lease for the month of March 2025. The waiting list is currently carrying 529 applicants. The report also indicated a current lease-up of 192 units (79.5%) for March 2025.

Portables: In-0, Out-2.

Grinde Manor June 2025

The report indicated 38 units (95%) under lease for the month of June 2025. The waiting list is currently carrying 19-1BR applicants. The report also indicated a current lease-up of 40 units (100%).

Grinde Manor July 2025

The report indicated 39 units (97.5%) under lease for the month of July 2025. The waiting list is currently carrying 19-1BR applicants. The report also indicated a current lease-up of 39 units (97.5%).

Fountain Townhomes June 2025

The report indicated 13 units (92.85%) under lease for the months of June 2025. The report also indicated a current lease-up of 13 units (92.85%). The waiting list is currently carrying 248 applicants.

Fountain Townhomes July 2025

The report indicated 11 units (78.57%) under lease for the months of July 2025. The report also indicated a current lease-up of 11 units (78.57%). The waiting list is currently carrying 248 applicants.

Fountain Mesa Court Townhomes June 2025

The report indicated 63 units (98.43%) under lease for the months of June 2025. The waiting list is carrying 8 applicants 7-2BR applications and 1-3BR applications. The report also indicated a current lease-up of 63 units (98.43%).

Fountain Mesa Court Townhomes July 2025

The report indicated 62 units (96.87%) under lease for the months of July 2025. The waiting list is carrying 8 applicants 7-2BR applications and 1-3BR applications. The report also indicated a current lease-up of 62 units (96.87%).

b. Maintenance

The report indicated that, during the month of June 2025, 10 work orders were processed at the Fountain Mesa Court Townhomes, 26 at Grinde Manor and 12 at the Fountain Townhomes. Yard work was performed at all sites as necessary.

The report indicated that, during the month of July 2025, 19 work orders were processed at the Fountain Mesa Court Townhomes, 37 at Grinde Manor and 22 at the Fountain Townhomes. The increase in work orders was due to both an NSPIRE and CHFA inspection. Yard work was performed at all sites as necessary.
